## INSTRUCCIONES DE USO

Es una contravención de la ley federal usar este producto de manera contraria a las instrucciones de la etiqueta.

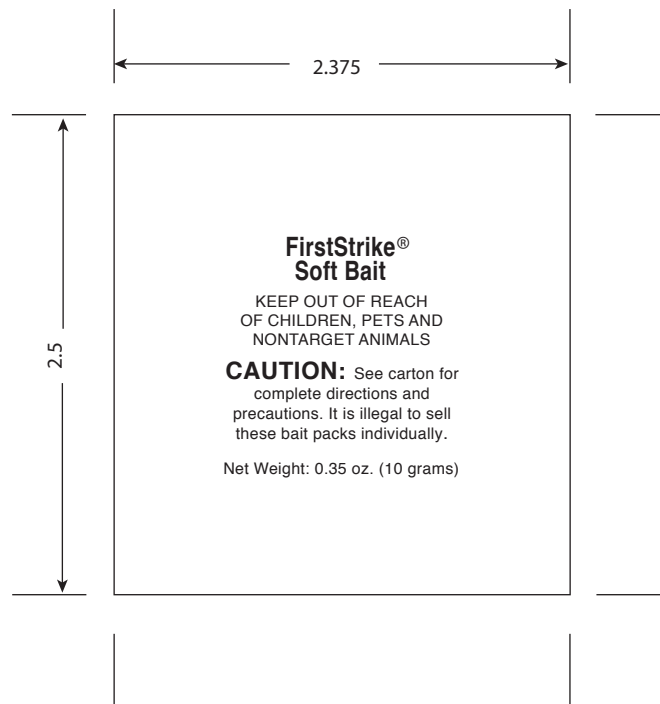
